

THE GATORADE NFL HAT INSTANT WIN GAME
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE AT LEAST THIRTEEN (13) YEARS OLD AT THE TIME OF ENTRY.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The Gatorade NFL Hat Instant Win Game ("Promotion") is sponsored by The Gatorade Company ("Sponsor"), 555 W. Monroe St., Chicago, IL 60661 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION PERIOD:** The Instant Win Game begins August 9, 2021 at 12:00 PM Eastern Time ("ET") and ends on March 13, 2022 at 11:59:59 PM ET ("Promotion Period"). Administrator's computer is the Promotion's official clock.
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least thirteen (13) years old at the time of entry. Officers, directors and employees of Sponsor, Administrator, Snapchat, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (all such individuals and entities collectively referred to herein as the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. HOW TO PARTICIPATE IN THE INSTANT WIN GAME:** To participate in the Instant Win Game, during the Promotion Period, eligible entrants must visit Gatoradehat.com and complete and submit the registration form including, but not limited to, complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP code, phone number, date of birth, and confirmation entrant has read and agrees to be bound by these Official

Rules. Entrant must then follow the links and instructions to select a football team after which he/she will receive one (1) game play (“Game Play”) for a chance to win a prize for the selected football team. After a valid Game Play, the entrant will receive an on-screen notification indicating whether he/she is a potential Instant Win Game prize winner (“Notification”). Each entrant who receives a winning Notification will be deemed a potential Instant Win Game prize winner subject to verification of the entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor in its sole discretion. An entrant is not a winner of any prize, even if the Notification should so indicate, unless and until entrant’s eligibility and the potential winning Game Play have been verified and entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. NOTE: During the Promotion Period, an entrant may receive a link to the Website by using the Snapchat app on his/her mobile device to scan the Snap code located on participating 28 oz End Zone Berry Gatorade and advertising material. An entrant may center the code in the camera and scan the Snapchat code. Once entrant scans the code, he/she may play the Road to the Dunk game (“Road to the Dunk Game”) within the Snapchat app. Once the Road to the Dunk Game is completed, entrant will receive a link to the Website, and may follow the steps noted above to participate in the Instant Win Game. **An entrant cannot participate in the Instant Win Game solely by scanning the Snapchat code.**

If an entrant does not have a Snapchat account, he/she can create one at no cost by downloading the Snapchat app on his/her smart phone or tablet device. Entrants should consult their wireless-service providers regarding their pricing plans. Message and data rates may apply. 4. PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE (“ARV”):

A. Instant Win Game Prizes (4,750 total): Each Instant Win Game prize is a Gatorade NFL New Era Hat with the team logo winner selected upon entry (each an “Instant Win Game Prize”). The number of Instant Win Game Prizes for each logo is outlined in the chart below:

No more than four thousand seven hundred fifty (4,750) total Instant Win Game Prizes will be available during the Promotion Period. The ARV of each Instant Win Game Prize is \$35.99.

- B. Total ARV:** The total ARV of all available prizes in the Promotion is \$170,952.50.
- C. Odds of Winning/Limit:** The odds of winning an Instant Win Game Prize depend on when the entrant completes a Game Play. Instant Win Game Prizes will be made available at random times throughout the Promotion Period. To be a potential winner of a Prize, an entrant's Game Play must have occurred either at the exact randomly predetermined winning time as determined by Sponsor and/or Administrator.
